PARK RULES & REGULATIONS  
PARK HOURS 6AM -10PM

**ALL CODE NUMBER HOLDERS:**

- You must be a member in good standing of the Coral Cove Civic Association. *If membership in CCCA ceases, the code number will be immediately disabled. The code number fee paid is **not** transferrable to a new owner/resident or another member.*
- Park code numbers are not to be given to another person.
- Use of the park for special events must be approved by the CCCA Board of Directors.
- Members may obtain a temporary pass for use of the ramp with 24 hour notice.

**BOATING AND RAMP RULES:**

- To use the ramp, you must be a CCCA member or a guest of and accompanied by a CCCA member.
- **Boat and trailer must be registered to a CCCA member. *Guest boat can be used if a temporary pass is obtained and member is present at all times.***
- **A code number will be issued upon receipt of dues and signed Park Rules & Regulations Agreement.**
  - Commercial use is prohibited.
  - Total load (boat and trailer) shall not exceed 12,500 lbs.
  - Boat draft is limited to 22" (motor up) per Sarasota County permit.
  - No boat maintenance of any type shall be done at the dock or in the park. (This includes filling gas and/or changing/adding oil.)
- Properly display your CCCA Boat Ramp stickers on your boat and trailer. (See sticker placement sheet)
- Boats shall not be left unattended at the dock.
- All vehicles shall park in designated parking area only. (See parking map)
- Only towing vehicles with an attached trailer can be left **unattended** within the park gates.
  - **A vehicle launching a kayak or small boat not trailered must park OUTSIDE the park.**
- Boating guests are to park OUTSIDE the park.
- Do not power load your boat. Keep noise to a minimum - be courteous of your neighbors.

**GENERAL:**

- Use the park, dock and ramp at your own risk; members take responsibility for their guests.
- Unauthorized use of the park constitutes trespass and will be treated as such.
- Violators are subject to towing and all associated costs.
- Violation of park rules will result in forfeiture of your code number and all park privileges for a 12 month period.
